## Nominating US Supreme Court justices: a broken process that needs fixing

The United States Supreme Court is a body that lacks representation, yet it is comprised of justices who hold contrasting views on how to interpret the Constitution and laws. This is a key factor in presidential nominations to the court.

However, the current system for selecting Supreme Court justices is flawed because it gives voters in some elections greater influence over appointments than in others. While the court does reflect the political values of the country over a long period of time, it is concerning that the size of the court remains fixed at nine, leading to unequal opportunities for presidents to nominate justices.

It would be fairer if each president had an equal number of appointments per term, and the size of the court fluctuated based on vacancies. The court usually decides cases based on historical sources, precedents, and accumulated wisdom, making it an important institution in interpreting the law.
